
#### CITY OF GLENDORA INVESTMENT REPORT SUMMARY November 30, 2023

Pursuant to California Government Code Section 53600 et seq. and Section 16 of the City of Glendora's Investment Policy, a monthly investment report must be provided to the City Council providing a clear picture of the status of the current investment portfolio. Included in the report are several specific items relating to portfolio holdings including, but not limited to, investment type, par value, market value, book value, coupon rate and yield to maturity.

The report is in conformity with the City's Investment Policy and California Government Code 53601. Per the policy, the report reflects pooled cash from all city funds. It does not reflect any restrictions associated with how each individual fund can be utilized. This information is provided through other financial reports that include the budget, Annual Comprehensive Financial Report and other financial reports available through the website.

The objective of the City investments is to provide safety of principal and liquidity, while then providing a return on investments. (Section 4 of the policy). All brokered transactions are held by a third-party custodian designated by the Treasurer. (Section 14 of the policy). There is currently one custodial account, which is UBS.







Pursuant to Section 19 of the City of Glendora's 2023-2024 Investment Policy, a monthly investment report must be provided to the City Council to provide a clear picture of the status of the current investment portfolio.

The second City Council meeting for the month of December 2023 has been canceled as decided by City Council. In order to be compliant with the City's policy and the California Government code, the November investment report is being provided to the Council members before the end of the month and will be placed on the next available council meeting scheduled in January, 2024.

The City's book value of cash and investments for November 2023 totaled \$116,993,020. This is a decrease of \$2,276,210 (1.91%) compared to the previous month. The month of November included significant payments for capital improvement projects and capital purchases in the amount of \$421,650, trees/parks/streets/streetlight maintenance in the amount of \$539,320 and 2019 Pension Obligation debt service payments in the amount to \$743,600 for grand total of \$1,704,570.

In November, one security was called or matured, however, the City did use its limited term government funds accounts (operates similar to a money market) and local agency investment funds (LAIF) in the amounts of \$1,208,000 and \$400,000, respectively, towards the large payments mentioned above resulting in neither a gain nor a loss. There were no investment purchases for the month of November.
