RESOLUTION CC 2022-45

A RESOLUTION OF THE CITY COUNCIL AMENDING THE CITY OF GLENDORA CONFLICT OF INTEREST CODE FOR 2022

THE CITY COUNCIL City of Glendora, California

WHEREAS, the Glendora City Council that also serve as the Successor Agency of the former Community Redevelopment Agency, Glendora Housing Authority and the Glendora Public Finance Authority previously adopted Resolution CC 2020-46, adopting by reference the model Conflict-of-Interest Code set forth in Section § 18730 of the California Code of Regulations; and

WHEREAS, the Governing Body desires to add positions that must be designated; revise the titles of existing positions; and revise the disclosure category of existing positions.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Rescind Resolutions CC 2020-46, CC 2020-46(SA), FN 2020-02, HA 2020-02 and any resolutions in conflict with this resolution are hereby rescinded and repealed.

SECTION 2. The Political Reform Act, Government Code Section § 81000, et seq., requires State and local government agencies to adopt and promulgate Conflict-of-Interest Codes. The Fair Political Practices Commission has adopted a regulation, 2 Cal. Code of Regs. Section § 18730, which contains the terms of a standard Conflict-of-Interest Code, which can be incorporated by reference, and which may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act after public notice and hearings. Therefore, the terms of 2 Cal. Code of Regs. Section § 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference and, along with the attached Exhibit A in which public officials and employees are designated and Exhibit B in which disclosure categories are set forth, constitute the Conflict-of-Interest Code of the City of Glendora, which is considered the "agency" within the purview of this code.

- **SECTION 3**. In 2013, the City of Glendora received authorization from the FPPC to file statements of economic interest with the FPPC electronically.
- **SECTION 4**. Designated employees shall file their statements with the City Clerk, who shall be and perform the duties of filing officer for the City of Glendora. Statements will be available for inspection and reproduction pursuant to Government Code Section § 81008. Statements for all designated employees will be retained by the City Clerk.
- **SECTION 5**. Exhibit A (Listing Government Code Section § 87200 et seq. [Regs. § 18730(b)(3)] Article II Filers and Designated Employees and their disclosure categories) attached hereto amend and supersedes all pervious Exhibit A attachments to the City's Conflict-of-Interest Code.
- **SECTION 6**. Exhibit B (Explanation of disclosure categories) attached hereto amends and supersedes all pervious Exhibit B attachments to the City's Conflict-of-Interest Code.

SECTION 7. The Mayor shall sign this Resolution and the City Clerk/Communications Director shall attest and certify to the passage and adoption of this Resolution; and the same shall take effect and be in force adoption by the City Council.

SECTION 8. The City Clerk/Communications Director is hereby directed to forward a copy of this resolution to the Glendora Human Resources Division.

Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements (See Consultant Conflict of Interest Questionnaire). The City Manager's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code.
