**NOTICE IS HEREBY GIVEN** that the Planning Commission will conduct a special meeting at 7:00 p.m. on November 22, 2010, in City Hall Council Chambers, 116 East Foothill Boulevard, Glendora, CA. The purpose of said special meeting is as follows:

1. Consideration of recommendations to the City Council for the following: Approval of Vesting Tentative Tract Map No. 66608 for 50 single-family lots (Case No. SUB10-01); and approval of Vesting Tentative Tract Map No. 66609 for 74 single-family lots (Case No. SUB10-02). (Applicant: MONROVIA NURSERY COMPANY; Location: +/- 95 acres of undeveloped land generally located north of the BNSF Railroad right-of-way, south of Sierra Madre Avenue, west of Barranca Avenue and east of the corporate boundary with the City of Azusa.) (Continued from the November 16, 2010, meeting.)

Open and conduct the Public Hearing, accept evidence and testimony presented, and in the absence of evidence and testimony to the contrary, make the following recommendations to the City Council: (1) Approval of a Resolution approving Subdivision (SUB10-01) - Vesting Tentative Tract Map 66608 for 50 single-family lots; and (2) Approval of a Resolution approving Subdivision (SUB10-02) - Vesting Tentative Tract Map 66609 for 74 single-family lots.
